Thereafter, the Board will do an annual assessment of the qualification of Directors who has served on the Board for a cumulative term of more than nine (9) years.</p> <p>The Board views that the Independent Non-Executive Directors of the Company have the vast experience in a diverse range of business to provide constructive opinion and exercise independent judgement.</p> <p>Overall, the Board believes that the above Directors possess the right balance of experience, expertise, skills and competencies to contribute strong independent judgment and check and balance to the Board with their unbiased and independent views to foster greater objectivity in the boardroom.
